Cookies

Cookies are small files that are downloaded to your computer when you visit a website to improve your experience. How do we use cookies?

We use cookies to manage functionality on our website and to have insights on how to improve our services for our users. When a cookie is not necessary, we give you the option to opt-out of it and disable it.

What types of cookies do we use?

We use two main types of cookies:

- Necessary cookies, which are essential for the operation of the website by enabling basic functions like page navigation and access to secure areas of the website.
- Statistic cookies, which allow us to see the number of visitors and how they move around our website when they are using it. This helps us to improve the way our website works, for example, by ensuring that users are finding what they are looking for easily. The analytics solution we have opted for preserves our visitor's privacy by e.g. anonymising IP addresses. The information collected by these cookies is aggregated and therefore anonymous.
